

**WRIGHT TOWNSHIP REGULAR BOARD MEETING MINUTES  
OCTOBER 14, 2015 – 7:30PM**

***The following minutes were taken at the October 14, 2015, Regular Board Meeting and are currently unapproved.***

1. The Meeting was called to order with a pledge and a prayer at 7:30 P.M. by Josh Westgate. Board members present: Josh Westgate, Theresa Frank, Tracy Worrell, Rick Schoenborn, and Gary Karr. No Parking in the reserved fire spots was announced.
2. No Additions to the Agenda.
3. a. Schoenborn motioned, and Karr supported the approval of the bills for \$35,476.26, and the Treasurer's report of Tax, Trust & Agency. Motion carried.  
b. Budget was reviewed.  
c. Schoenborn motioned, and Karr supported the approval of September 9, 2015, Regular Board Meeting minutes as written. Motion carried. The Minutes for October 8<sup>th</sup> Special Meeting will be available for approval at the November 11, 2015 Regular Board Meeting.
4. No public comments for any items not on the agenda.
5. Derry Hallmark, from Serenity Point Recovery was at the board meeting for the quarterly meeting agreed upon between the Township and Serenity Point at the time of mediation. Worrell brought up the fact that groups of patients walking along 16<sup>th</sup> avenue around the curve could be a safety issue. Mr. Hallmark agreed. The Musketawa trail was brought up, letting him know there was parking on 8<sup>th</sup> Ave., and they could use their bus for transport, and would be much safer.
6. Worrell motioned to contribute \$1,155.00, to Lakeshore Advantage for this year's contribution. Karr supported. The motion was carried.
7. Schoenborn motioned to appoint Todd Kempf, as an additional Building Inspector with IMS. Worrell supported. Motion carried.
8. Karr motioned to accept the Assessor Inspection of Records Policy. Frank supported. Motion carried.
9. Schoenborn motioned and Karr supported the reappointment of Barb Saunier to the Historical Commission 2015-2018 term. Motion carried.
10. Worrell motioned to approve the January, 2016, MTA Conference in Detroit. Schoenborn supported and motion carried.

11. Reports were given. Karr reported that the Planning Commission had three meetings last month.
12. Supervisor reported that he worked with Consumers Energy to get a large credit for the Township. It was because Westgate had them do a new count of street light to make sure we were being charged correctly. We were being charged for the wrong amount and the credit was retroactive.  
Per Westgate preparations for the fire department's Halloween party are going well.  
More clean ups in the Cemeteries are coming up. Some new fencing at the property borders in the Marne Cemetery was discussed.  
At the end of Supervisors report he let the board know that Sherriff Rosema, will be retiring.
